

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Employment & Training Program PY 04/FY 05 Annual Program**  
**Budgets/Comprehensive Service Plan/State Contract/Native Employment Work Plan)**

RESOLUTION NO. 04-228

1 **WHEREAS, the Department of Labor – Comprehensive Service Plan and Annual Budget has been**  
2 **developed with current allocation in the amount of \$463,532.00 beginning July 1, 2004**  
3 **and ending June 30, 2007; and**

4 **WHEREAS, the Department of Labor – Supplemental Youth Service Plan and Annual Budget**  
5 **has been developed with current allocation in the amount of \$ 148,792.00**  
6 **beginning June 1, 2004 and ending June 30, 2007; and**

7 **WHEREAS, the Arizona Department of Economic Security – Adult and Youth PY 04 and FY 05**  
8 **Annual Budgets have been developed with State suggested allocations in the amount**  
9 **of \$196,341.00 with a modification and contract submittal once final allocation**  
10 **figures have been received by the program; and**

11 **WHEREAS, the Department of Health and Human Services Annual Budget and plan has been**  
12 **developed in the amount of \$150,868.00 beginning July 1, 2004 and ending June 30,**  
13 **2007.**

14 **NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
15 **approve the Employment & Training Annual Budgets/Comprehensive Service Plan**  
16 **and Budget PY 2004 in the amount of \$463,532.00; Department of Labor**  
17 **Supplemental Youth Service Budget PY 2004 in the amount of \$148,792.00;**  
18 **Department of Health and Human Services Native Employment Works Budget and**  
19 **Plan PY 2004 in the amount of \$150,868.00; and Arizona Department of Economic**  
20 **Security WIA PY04/FY05 in the amount of \$196,341.00 in the combined amount of**  
21 **\$959,533.00 and authorized to incur expenditures upon approval of this**  
22 **resolution.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation's Officials, to wit; the Chairwoman is hereby authorized to negotiate and**  
25 **execute the contracts and plans, provided however, that any amendment affecting**  
26 **the funding or funding levels of this contract shall be submitted for further prior**  
27 **approval by this Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day**  
29 **of JUNE, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
30 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
31 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
32 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
33 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
