8		establishment of the Data Improvement Program under the Special Diabetes
9		Programs for Indians, authorized by the Balanced Budget Act of 1997; and
10	WHEREAS,	by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved
11		$the  name  change  of  the  \underline{Community  Based  Diabetes  Program}  to  the  \underline{Healthy  O'odham}$
12		Promotion Program; and
13	WHEREAS,	the Tohono O'odham Department of Health and Human Services is requesting the
14		Fiscal Year 2004 base budget of \$1,929,827.00, Carry over funding of \$1,911,625.15,
15		and \$77,559.00 in additional funding to operate the Healthy O'odham Promotion
16		Program.
