

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Consolidated Healthy O'odham Promotion Program and Data Improvement  
Project FY 2004 Budget Amendment (October 1, 2003 – September 30, 2004))**

**RESOLUTION NO. 04-232**

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant**  
2 **through FY 2009 with a base budget of \$1,929,827; and**

3 **WHEREAS, by Resolution No. 99-149, the Tohono O'odham Legislative Council approved the**  
4 **establishment of the Community Based Diabetes Prevention Program, funded by the**  
5 **Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of**  
6 **1997; and**

7 **WHEREAS, by Resolution No. 98-150, the Tohono O'odham Legislative Council approved the**  
8 **establishment of the Data Improvement Program under the Special Diabetes**  
9 **Programs for Indians, authorized by the Balanced Budget Act of 1997; and**

10 **WHEREAS, by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved**  
11 **the name change of the Community Based Diabetes Program to the Healthy O'odham**  
12 **Promotion Program; and**

13 **WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the**  
14 **Fiscal Year 2004 base budget of \$1,929,827.00, Carry over funding of \$1,911,625.15,**  
15 **and \$77,559.00 in additional funding to operate the Healthy O'odham Promotion**  
16 **Program.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 18 **1. Approves the Healthy O'odham Promotion Program Fiscal Year 2004 budget**  
19 **amendment for \$3,915,823.15.**
- 20 **2. The Tohono O'odham Nation Officials, to wit: the Chairwoman and Vice**  
21 **Chairman and any designated Official is hereby authorized to negotiate and**  
22 **execute the contract and expend funds associated with this budget.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
24 **of JUNE, 2004 at a meeting at which a quorum was present with a vote of 2,049.2 FOR; -0- AGAINST;**  
25 **580.5 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (¶)**  
26 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
