

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Repealing Resolution 04-083 which approved Amendment No. 1 to Attorney
Contract with Clapham & Curry, P.L.C.)**

RESOLUTION NO. 04-234

1 **WHEREAS, pursuant to Legislative Council Resolution No. 03-507, the Tohono O'odham Nation**
2 **(the "Nation") entered into an Attorney Contract with the law firm of Clapham &**
3 **Curry, P.L.C. (the "Attorneys") in the amount of \$60,000 for the period from November**
4 **10, 2003 to March 31, 2004; and**

5 **WHEREAS, pursuant to Legislative Council Resolution No. 04-083, Amendment No. 1 to the**
6 **Attorney Contract was approved which increased the Contract amount from \$60,000**
7 **to \$120,000 and extended the Contract term through September 30, 2004; and**

8 **WHEREAS, the final billing of the Attorneys through March 9, 2004 has been paid; and**

9 **WHEREAS, the unexpended balance under the Attorney Contract is \$71,467; and**

10 **WHEREAS, the Attorney General recommends the repeal of Resolution 04-083, deobligation of**
11 **the unexpended balance under the Attorney Contract and authorization to transfer**
12 **such balance to the professional services line item (01-1031-810) in the fiscal year**
13 **2004 budget of the Office of Attorney General; and**

14 **WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval of this**
15 **Resolution by the Legislative Council.**

16 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 17 **1. The Tohono O'odham Legislative Council hereby repeals Resolution No. 04-083.**
18 **2. The Accounting Department is authorized and directed to deobligate the**
19 **unexpended balance under the Attorney Contract in the amount of \$71,467 and**
20 **to transfer such balance for expenditure to the professional services line item**
21 **(01-1031-810) in the fiscal year 2004 budget of the Office of Attorney General.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
23 **of JUNE, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1**
25 **(d)(2)&(3) and 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
