

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Attorney Contract with Paul J. Matte III Relating to Indian Child Welfare Act Proceedings in Maricopa County Juvenile Court)**

RESOLUTION NO. 04-235

1 WHEREAS, additional representation is required to adequately protect the interests of the  
2 Tohono O'odham Nation (the "Nation") in proceedings under the Indian Child Welfare  
3 Act which are pending in the Maricopa County Juvenile Court; and

4 WHEREAS, the Attorney General recommends the engagement of Paul J. Matte III to provide such  
5 representation under an Attorney Contract in the amount of \$10,000 for the period  
6 from June 15, 2004 through September 30, 2004; and

7 WHEREAS, the budget for the Office of Attorney General (01-1031-810) has sufficient funds for the  
8 Contract amount; and

9 WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval of the  
10 Attorney Contract by the Legislative Council.

11 NOW, THEREFORE, BE IT RESOLVED THAT:

- 12 1. The Tohono O'odham Legislative Council approves the Attorney Contract with  
13 Paul J. Matte III, in the form attached hereto, in the amount of \$10,000 for the  
14 period from June 15, 2004 through September 30, 2004.
- 15 2. Funding for the Attorney Contract shall be provided from the budget of the Office  
16 of Attorney General (01-1031-810).
- 17 3. The Chairwoman of the Nation is authorized and directed to execute the Attorney  
18 Contract.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day  
20 of JUNE, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;  
21 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of  
22 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
23 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
24 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
