

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2005 Projected Revenues in the Amount of \$49,493,008)**

**RESOLUTION NO. 04-323**

1 WHEREAS, the Budget & Finance Committee, Executive Review Committee and Tri-Branch  
2 Representatives reviewed the revenue projection and available revenues for FY 2005;  
3 and

4 WHEREAS, the Budget & Finance Committee, and Legislative and Judicial Representatives  
5 recommend adoption of FY 2005 revenues projected and available in the amount of  
6 \$49,493,008 to fund the Nation's budget for 2005.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
8 approves the attached projected revenues in the amount of \$49,493,008 for the  
9 purpose of funding the FY 2005 budgets of the Tohono O'odham Nation.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day  
11 of JULY, 2004 at a meeting at which a quorum was present with a vote of 2,447.65 FOR; 182.05  
12 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
13 Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
14 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
16 18, 1934 (48 Stat. 984).


