9		attached and represent an increase of \$8,951.35 in total District distributions; and				
10	WHEREAS,	District distributions are to be disbursed on August 1, 2004 and the final District				
11		distribution numbers will not be available until August 30, 2004, therefore resulting				
12		in some minor fluctuations in comparison to Report 2, which is attached; and				
13	WHEREAS,	there was an error in the amount of \$29,562.34 in prior distributions due to the San				
14		Xavier District, with the corresponding reductions in the other Districts, which is				
15		included in the projected FY 2005 distributions and is identified in Report 1 and				
16		Report 2, the later of which is attached; and				
17	WHEREAS,	the Legislative Council does hereby approve distribution of gaming revenues by				
18		population distribution.				
19	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby					
20		approves and authorizes the FY 2005 distribution of gaming revenues by population				
21		distribution.				
22	BE IT FURTHER RESOLVED that the total calculated District distributions for the period of August					
23		2003 to July 2004 will be adjusted for the error in prior distributions totaling				
24		\$29,562.34 as seen in the attached Report 2.				
25	BE IT FINAL	LY RESOLVED that the Chairwoman of the Nation, the Budget & Finance Committee,				
26		and the Treasurer resolve the amount owed to San Xavier District and that the matter				
27		be brought back to the Tohono O'odham Legislative Council for approval within three
