

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Tohono O'odham Legislative Council Resolution No. 04-289 and Approving
the Equal Distribution of \$94,757.44 from the El Paso Gas Pipeline Funds to the Seven
Hickiwan District Communities)

RESOLUTION NO. 04-326

- 1 **WHEREAS, on July 8, 2004, the Hickiwan District Council met with the Office of the Chairwoman,**
2 **the Office of the Treasurer, the Nation's Accounting Department, and Legislative**
3 **Council Representatives to evaluate the Hickiwan District's financial situation; and**
- 4 **WHEREAS, the Hickiwan District Council held a special session on July 9, 2004 to discuss the**
5 **financial situation of the District; and**
- 6 **WHEREAS, the Legislative Council by Resolution No. 04-289 approved the appropriation of El**
7 **Paso Gas Pipeline funds to supplement the Hickiwan District Administration and**
8 **Operations for the fourth quarter of FY-2004; and**
- 9 **WHEREAS, the Hickiwan District Council by Resolution #07-01-04 rescinded Resolution #06-02-**
10 **04 approving the use of the El Paso Gas Funds to supplement the Hickiwan District**
11 **Administration and Operations; and**
- 12 **WHEREAS, the date on which the El Paso Gas Pipeline funds will be available to the District is**
13 **uncertain; and**
- 14 **WHEREAS, by Resolution No. 04-329, the Legislative Council authorized an early distribution of**
15 **gaming revenues and approved a fourth quarter FY-2004 interim budget for the**
16 **Hickiwan District; and**
- 17 **WHEREAS, the Hickiwan District Council by Resolution #07-03-04 approved the distribution of**
18 **the El Paso Gas Pipeline Funds to each of the seven (7) communities of the Hickiwan**
19 **District of \$13,536.77 totaling \$94,757.44; and**
- 20 **WHEREAS, the Hickiwan District Council by Resolution #07-03-04 approved the budgets of the**
21 **seven Hickiwan District communities for the use of the El Paso Gas Pipeline funds;**
22 **and**
- 23 **WHEREAS, by Resolution #07-01-04 the Hickiwan District Council requests the Legislative**
24 **Council to rescind Resolution No. 04-289 and further requests, pursuant to Hickiwan**
25 **District Council Resolution #07-03-04, that the Legislative Council approve the use of**
26 **the El Paso Gas Pipeline Funds of the Hickiwan District in accordance with Hickiwan**
27 **District Resolution #07-03-04.**

1 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
2 rescinding Resolution No. 04-289 which authorizes the appropriation of \$94,757.44
3 from the El Paso Gas Pipeline Funds to supplement the Hickywan District
4 Administration and Operations for a three-month period.

5 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council now approves
6 reappropriating the El Paso Gas Pipeline Funds of \$94,757.44 to the Seven (7)
7 Communities of the Hickywan District.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day
9 of JULY, 2004 at a meeting at which a quorum was present with a vote of 2,370.8 FOR; -0- AGAINST;
10 258.9 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1
11 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
12 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
13 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
14 Stat. 984).


