

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointment of Sandra R. Johnson as TERO Commissioner)**

**RESOLUTION NO. 04-330**

1 **WHEREAS, the Tohono O'odham Legislative Council pursuant to Section 6(B)(1) of the TERO**  
2 **Ordinance No. 01-85 appoint Commissioners for a three year term or until their**  
3 **successors are appointed and qualified; and**

4 **WHEREAS, the Domestic Affairs Committee is the oversight committee for "all TERO matters"**  
5 **pursuant to Resolution No. 98-448 authorized by this Council; and**

6 **WHEREAS, the Domestic Affairs Committee conducted a Commissionership search to address**  
7 **the expired term by publicly announcing the one vacancy to all Districts and**  
8 **requested that nominations be submitted for their consideration; and**

9 **WHEREAS, the Domestic Affairs Committee did receive three (3) nominations to fill the one**  
10 **vacancy.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
12 **appoints Sandra R. Johnson as TERO Commissioner pursuant to Section 6(B)(1) & (C)**  
13 **of the TERO Ordinance No. 01-85, commencing upon effective date of this resolution**  
14 **and expiring on April 2007.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>. Day**  
16 **of JULY, 2004 at a meeting at which a quorum was present with a vote of 1,679.6 FOR; 758.2**  
17 **AGAINST; 191.4 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
18 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**
