

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override of Vetoed Resolution No. 04-296, 'Supporting the Grant Application to the
National Science Foundation of Colleen Fitzgerald of Texas Tech University to Fund
Five Years of Linguistic Research to Prepare a Large Set of Previously Unpublished
Tohono O'odham Texts, Located at Various Libraries, Archives and Museums
in the United States')**

**FAILED
RESOLUTION NO. 04-333**

1 **WHEREAS, during the July 12, 2004 General Session of the Tohono O'odham Legislative Council,**
2 **the Council did pass Resolution No. 04-296; and**

3 **WHEREAS, upon presentation of Resolution No. 04-296 to the Chairwoman of the Tohono**
4 **O'odham Nation, she did disapprove thereof and returned it to the Council with her**
5 **objections in accordance with the provisions of Article VII, Section 5 of the**
6 **Constitution of the Tohono O'odham Nation; and**

7 **WHEREAS, during the July 19, 2004 General Session, the Chairwoman of the Nation presented to**
8 **the Legislative Council her justification in vetoing Resolution No. 04-296, a copy of**
9 **which is attached hereto; and**

10 **WHEREAS, the Legislative Council reviewed the Chairwoman's objections and after**
11 **consideration, again voted to pass Resolution No. 04-296.**


12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **override the Chairwoman's veto by a vote of two-thirds of the votes cast in accordance**
14 **with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham**
15 **Nation.**

16 **The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 19TH.**
17 **day of JULY, 2004 at a meeting at which a quorum was present, and by a vote of 1,096.9 FOR; 1,532.8**
18 **AGAINST; -0- NOT VOTING; and [03] ABSENT, failed to pass because it did not receive a majority of**
19 **two-thirds (2/3) [1,753.13] of the votes cast as required by Section 5 of Article VII of the Constitution**
20 **of the Tohono O'Odham Nation.**
