

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2004 Department of Human Services - Division of Behavioral Health**  
**Account #10-1473 - Budget Amendment #1)**

**RESOLUTION NO. 04-336**

1 **WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating**  
2 **the Division of Behavioral Health Component under P.L. 93-638 Master Health**  
3 **Contract with the Public Health, Indian Health Services; and**

4 **WHEREAS, the Division of Behavioral Health has a budget approval under Resolution No. 03-435**  
5 **in the amount of Direct Cost \$2,724,061.76 plus estimated Indirect Cost \$311,768.44**  
6 **= total amount of \$3,035,830.20; and**



7 **WHEREAS, the Division of Behavioral Health is submitting for review and approval budget**  
8 **amendment # 1 in the amount of Direct Cost \$2,724,061.76 plus Indirect Cost**  
9 **\$311,768.44 = \$3,035,830.20 moving savings from vacant positions and adjustment of**  
10 **salaries of counselors who have obtained state certification. Also applying savings**  
11 **to other program line items and to cover the cost of division move and modular**  
12 **building.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 14 **1. It hereby approves and authorizes expenditures in the amount of Direct Cost**  
15 **\$2,724,061.76 plus Indirect Cost \$311,768.44 = \$3,035,830.20 in accordance with**  
16 **attached budget amendment #1.**
- 17 **2. The Tohono O'odham Nation's Officials to wit: the Chairwoman is hereby**  
18 **authorized to negotiate and execute the contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup> Day**  
20 **of JULY, 2004 at a meeting at which a quorum was present with a vote of 2,448.25 FOR; 181.45**  
21 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section**  
22 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
