

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2004 BIA Indian Child Welfare Act Budget Modification #1)**

RESOLUTION NO. 04-337

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **United States Department of the Interior, Bureau of Indian Affairs (BIA); and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a**
4 **Division of Child Welfare Services to intervene and provide services in furtherance**
5 **of the Indian Child Welfare Act; and**

6 **WHEREAS, in Resolution No. 03-436, the Legislative Council approved the FY 2004 BIA Indian**
7 **Child Welfare Act Budget in the total amount of \$235,909.66, inclusive of all direct and**
8 **indirect costs; and**


9 **WHEREAS, the Executive Branch developed and obtained committee approval of the budget**
10 **modification attached and incorporated by this reference, to be effective October 1,**
11 **2003 through September 30, 2004 and request authorization to expend funds.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve and authorize the Executive Branch to expend funds for the budget**
14 **modification referenced herein above and as attached in the amount indicated,**
15 **effective October 1, 2003 through September 30, 2004.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairwoman,**
17 **Vice-Chairman and any designated official are hereby authorized to negotiate,**
18 **execute and expend the grant.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH Day**
20 **of JULY, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
22 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
23 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
24 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
