

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 04-329 Authorizing the Early Distribution of Gaming Revenue**  
**to the HICKIWAN District and Approving an Interim Budget for the HICKIWAN District)**

**RESOLUTION NO. 04-348**

1 **WHEREAS, by Resolution No. 04-324, the Legislative Council did approve the distribution of**  
2 **gaming revenues by population, later vetoed by the Chairwoman of the Nation on July**  
3 **22, 2004, and not overturned by Council through Resolution No. 04-344; and**

4 **WHEREAS, by Resolution No. 04-329, the Legislative Council did approve an early distribution of**  
5 **gaming revenues to the HICKIWAN District in the amount of \$204,102.90; and**

6 **WHEREAS, no early distribution of gaming revenues was provided to the HICKIWAN District due**  
7 **to the vetoing of Resolution No. 04-324 and no explicit authority for the Treasurer to**  
8 **establish bank accounts for the HICKIWAN District; and**

9 **WHEREAS, it is critical that the HICKIWAN District resume normal operations in this unique**  
10 **situation; and**

11 **WHEREAS, the financial management of the District was transferred to the Nation by Resolution**  
12 **No. 04-327.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
14 **No. 04-329 is hereby amended as follows:**

15 **The first resolved clause is amended to read that the Tohono O'odham Legislative**  
16 **Council authorizes an early distribution of gaming revenues to the HICKIWAN District**  
17 **in the amount of \$204,102.90 regardless if there are any delays in the authorization**  
18 **of FY 2005 gaming revenues distributions as a whole. The Treasurer of the Nation is**  
19 **authorized to open an investment account and a checking account for the HICKIWAN**  
20 **District at Bank of America to accommodate the handling of the distribution and the**  
21 **financial management of the District.**

22 **BE IT FINALLY RESOLVED that the amount of \$204,102.90 will be subtracted from the District's FY**  
23 **2005 district distribution.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup>. Day**  
25 **of AUGUST, 2004 at a meeting at which a quorum was present with a vote of 1,734.4 FOR; 719.2**  
26 **AGAINST; 176.1 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**
