5 **Legislative Council; and**


6 **WHEREAS, the Sif Oidak District requests that the Tohono O'odham Legislative Council approve**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
9 **continued operations for the Sif Oidak District FY 04 Budget for thirty days (30) to**
10 **August 31, 2004 pending approval of the Sif Oidak District FY 05 Budget.**

11 **BE IT FINALLY RESOLVED that the Sif Oidak District does have sufficient funds to operate during**
12 **this period.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND. Day**
14 **of AUGUST, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**


