1	WHEREAS, the Tohono O'odham legislative Council is vested with the power to "establish rules
2	and procedures to regulate all meetings of the Tohono O'odham Council" pursuant
3	to Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and
4	WHEREAS, the Legislative Council has heard the presentation from the San Xavier Cooperative
5	Association regarding the financial request for \$6 million dollars from SAWRSA; and
6	WHEREAS, the Legislative Council denied the request at the June General Session and
7	subsequent discussion have since taken place with the parties regarding the financial
8	request and debt to the Nation.
9	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby sets
10	a Special Session on August 16, 2004 to address the financial request from the San
11	Xavier Cooperative Association.
