

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sif-Oidak District FY'05 Budget)

RESOLUTION NO. 04-367

1 **WHEREAS, the Sif-Oidak District Council by Resolution No. 08-04-02 approved the District FY '05**
2 **Budget in the amount of \$1,312,140.88 which includes the El Paso Gas Line Right-of-**
3 **Way payment in the amount of \$115,814.65; and**

4 **WHEREAS, the District Council has authorized the use of the District's Investment Savings in the**
5 **amount of \$926,326.23 and the carry over funds in the amount of \$270,000 from FY**
6 **'04 Budget pending the Gaming Revenue Distribution; and**

7 **WHEREAS, the El Paso Gas Line Right-of-Way Payment will be transferred to the Sif-Oidak**
8 **District Account for expenditures upon receipt by the Tohono O'odham Nation**
9 **Treasury with an approved budget.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**
11 **approve the Sif-Oidak District FY '05 Budget in the amount of \$1,312,140.88.**

12 **BE IT FURTHER RESOLVED that the budget includes the Investment Savings of \$926,326.23; Carry**
13 **over funds of \$270,000 and the El Paso Gas Line Right-of-Way payment of \$115,814.65.**


14 **BE IT FURTHER RESOLVED that the El Paso Gas Line Right-of-Way Budget will be expended once**
15 **the funds are wire transferred to the Sif-Oidak District Account #7392-8453 by the**
16 **Tohono O'odham Nation Treasury.**

17 **BE IT FURTHER RESOLVED that it does hereby approve the Sif-Oidak District's request to deposit**
18 **via wire transfer to account #7392-8453, the Sif Oidak District's full allocation of the**
19 **Gaming Revenues upon enactment by this Council.**

20 **BE IT FINALLY RESOLVED that this budget will be retroactive to August 1, 2004.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day**
22 **of AUGUST, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**
