

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Reappointment of Mr. Richard Ramirez to the Tohono O'odham**  
**Nursing Care Authority Board of Directors)**

**RESOLUTION NO. 04-382**

1 **WHEREAS, the Tohono O'odham Nursing Care Authority Charter was adopted by Legislative**  
2 **Council Resolution No. 98-512 which requires the Chairman of the Nation to appoint**  
3 **Directors to the Tohono O'odham Nursing Care Authority Board, with the approval**  
4 **of the Legislative Council; and**

5 **WHEREAS, the Chairwoman of the Nation has researched, identified and determined that Mr.**  
6 **Richard Ramirez is both willing and qualified to continue to serve as one of the**  
7 **Directors to the Tohono O'odham Nursing Care Authority Board; and**

8 **WHEREAS, the Chairwoman of the Nation does hereby reappoint Mr. Richard Ramirez to the**  
9 **Tohono O'odham Nursing Care Authority Board; and**

10 **WHEREAS, the Legislative Health & Human Services Committee and Legislative Rules Committee**  
11 **have both reviewed the Chairwoman's reappointment.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
13 **Chairwoman's reappointment of Mr. Richard Ramirez to Tohono O'odham Nursing**  
14 **Care Authority Board whose term shall commence on August 1, 2003 and expire on**  
15 **July 31, 2007.**

16 **BE IT FINALLY RESOLVED that Mr. Richard Ramirez shall exercise authority and possess**  
17 **responsibility as granted and described by the Tohono O'odham Nursing Care**  
18 **Authority Charter.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day**  
20 **of AUGUST, 2004 at a meeting at which a quorum was present with a vote of 1,801.8 FOR; 827.9**  
21 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
