**(Approving Distribution of Gaming Revenues by Population)**

RESOLUTION NO. 04-383

1 WHEREAS, during the August 06, 2004 General Session, the Sells District did present for  
2 consideration by the Legislative Council the recommendation to the distribution of  
3 gaming revenues, by per capita/population distribution; and

4 WHEREAS, the Legislative Council does hereby approve distribution of gaming revenues by  
5 population.

6 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
7 approves and authorizes the distribution of gaming revenues by population to the  
8 districts retro to August 01, 2004.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day  
10 of AUGUST, 2004 at a meeting at which a quorum was present with a vote of 1,342.2 FOR; 1,287.5  
11 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
12 Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
13 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
15 18, 1934 (48 Stat. 984).


