9		to the Legislative Council her justification in vetoing Resolution No. 04-370, a copy
10		of which is attached hereto; and
11	WHEREAS,	the Legislative Council reviewed the Chairwoman's objections and after
12		consideration, again voted to pass Resolution No. 04-370.
13	NOW, THER	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
14		override the Chairwoman's veto by a vote of two-thirds of the votes cast in accordance
15		with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham Constitution of the Consti
16		Nation.
