

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override of Vetoed Resolution No. 04-370, "Appointing Willard R. Manuel to the
Tohono O'odham Ki:Ki Association Board of Directors")

FAILED
RESOLUTION NO. 04-393

1 **WHEREAS, during the August 6, 2004 General Session of the Tohono O'odham Legislative Council,**
2 **the Council did pass Resolution No. 04-370, "Appointing Willard R. Manuel to the**
3 **Tohono O'odham Ki:Ki Association Board of Directors"; and**

4 **WHEREAS, upon presentation of Resolution No. 04-370 to the Chairwoman of the Tohono**
5 **O'odham Nation, she did disapprove thereof and returned it to the Council with her**
6 **objections in accordance with the provisions of Article VII, Section 5 of the**
7 **Constitution of the Tohono O'odham Nation; and**

8 **WHEREAS, during the August 16, 2004 Special Session, the Chairwoman of the Nation presented**
9 **to the Legislative Council her justification in vetoing Resolution No. 04-370, a copy**
10 **of which is attached hereto; and**

11 **WHEREAS, the Legislative Council reviewed the Chairwoman's objections and after**
12 **consideration, again voted to pass Resolution No. 04-370.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
14 **override the Chairwoman's veto by a vote of two-thirds of the votes cast in accordance**
15 **with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham**
16 **Nation.**

17 **The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 16TH,**
18 **day of AUGUST, 2004 at a meeting at which a quorum was present, and by a vote of 1,273.5 FOR;**
19 **1,180.1 AGAINST; 176.1 NOT VOTING; and [-0-] ABSENT, failed to pass because it did not receive a**
20 **majority of two-thirds (2/3) [1,753.13] of the votes cast as required by Section 5 of Article VII of the**
21 **Constitution of the Tohono O'Odham Nation.**
