

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Override of Vetoed Resolution No. 04-374, "Appointing Janice B. Pablo to the  
Tohono O'odham Ki:Ki Association Board of Directors")

**FAILED**  
**RESOLUTION NO. 04-394**

1 **WHEREAS, during the August 6, 2004 General Session of the Tohono O'odham Legislative Council,**  
2 **the Council did pass Resolution No. 04-374, "Appointing Janice B. Pablo to the Tohono**  
3 **O'odham Ki:Ki Association Board of Directors"; and**

4 **WHEREAS, upon presentation of Resolution No. 04-374 to the Chairwoman of the Tohono**  
5 **O'odham Nation, she did disapprove thereof and returned it to the Council with her**  
6 **objections in accordance with the provisions of Article VII, Section 5 of the**  
7 **Constitution of the Tohono O'odham Nation; and**

8 **WHEREAS, during the August 16, 2004 Special Session, the Chairwoman of the Nation presented**  
9 **to the Legislative Council her justification in vetoing Resolution No. 04-374, a copy**  
10 **of which is attached hereto; and**

11 **WHEREAS, the Legislative Council reviewed the Chairwoman's objections and after**  
12 **consideration, again voted to pass Resolution No. 04-374.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
14 **override the Chairwoman's veto by a vote of two-thirds of the votes cast in accordance**  
15 **with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham**  
16 **Nation.**

17 **The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 16<sup>TH</sup>,**  
18 **day of AUGUST, 2004 at a meeting at which a quorum was present, and by a vote of 1,329.2 FOR;**  
19 **1,124.4 AGAINST; 176.1 NOT VOTING; and [-0-] ABSENT, failed to pass because it did not receive a**  
20 **majority of two-thirds (2/3) [1,753.13] of the votes cast as required by Section 5 of Article VII of the**  
21 **Constitution of the Tohono O'Odham Nation.**
