

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tohono O'odham Advocate Program's Request for Budget**  
**Modification/Amendment #1)**

**RESOLUTION NO. 04-401**

1 **WHEREAS, the Tohono O'odham Nation (hereinafter referred to as the "Nation") established the**  
2 ***Tohono O'odham Advocate Program* to provide legal assistance to members of the**  
3 **Nation; and**

4 **WHEREAS, the *Tohono O'odham Advocate Program* has come before the Legislative Council**  
5 **requesting approval to modify their budget to add a new line item (750) to purchase**  
6 **a copier by transferring funds from salaries to a new capital account (750); and**

7 **WHEREAS, the Executive Office has reviewed and recommended its approval of the *Tohono***  
8 ***O'odham Advocate Program's* request; and**

9 **WHEREAS, the Domestic Affairs and Budget & Finance Committees have met, reviewed, and**  
10 **recommended their approval of the *Tohono O'odham Advocate Program's* request.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council recommends**  
12 **the approval of Tohono O'odham Advocate Program's Budget Modification/**  
13 **Amendment #1 to add new line item (750) -Major Capital.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day**  
15 **of AUGUST, 2004 at a meeting at which a quorum was present with a vote of 2,544.55 FOR; 85.15**  
16 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
17 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
20 **18, 1934 (48 Stat. 984).**


