

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Cancelling Special Session set for August 23, 2004 For Enrollment Rejection Hearings)**

**LEGISLATIVE ORDER NO. 04-402**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**  
2 **and procedures to regulate all meetings of the Tohono O'odham Council" pursuant**  
3 **to Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, the Legislative Council pursuant to Legislative Rules, Article I, Section 1(D)(1), by**  
5 **majority vote, called for a Special Session to be held for the purpose of conducting**  
6 **Enrollment Rejection Hearings; and**

7 **WHEREAS, pursuant to Legislative Order No. 04-224 a special session was set for August 23, 2004**  
8 **to conduct Enrollment Rejection Hearings pursuant to Article VIII, 1(B) of the**  
9 **Enrollment Ordinance; and**


10 **WHEREAS, the Legislative Council Rules Committee Chairperson was notified on August 13, 2004**  
11 **that the Enrollment Committee failed to meet the twenty (20) day requirement for**  
12 **notification to the applicants for the rejection hearing set for August 23, 2004; and**

13 **WHEREAS, the Rules Committee of the Legislative Council requests that the special session set**  
14 **for August 23, 2004 be cancelled.**

15 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby cancels**  
16 **the Special Session now set for August 23, 2004.**

17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day of**  
18 **AUGUST, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
19 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (b) of**  
20 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
