

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Legislative Order No. 04-201, "Certifying the Appointment of Rosita N. Ruiz
as Legislative Council Secretary")**

**DEFEATED
LEGISLATIVE ORDER NO. 04-404**

1 **WHEREAS, on May 07, 2004, the Legislative Council by Legislative Order No. 04-201 did appoint**
2 **Rosita N. Ruiz as the Legislative Council Secretary; and**

3 **WHEREAS, the appointment provides for a six - month evaluation period ending November 2004;**
4 **and**

5 **WHEREAS, the Legislative Secretary has the responsibility of maintaining official documents of**
6 **the Nation; and**

7 **WHEREAS, a concern was raised regarding the work performance of the Secretary and her**
8 **responsibility to ensure the integrity of the Nation's records.**

9 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council does hereby**
10 **rescind Legislative Order No. 04-201, in effect rescinding the appointment of Rosita**
11 **N. Ruiz as Council Secretary.**

12 **BE IT FURTHER ORDERED that the six - month evaluation period provided for in Legislative Order**
13 **No. 04-201 is hereby waived.**

14 **BE IT FINALLY ORDERED that the Legislative Branch Administration shall re-advertise the**
15 **Legislative Council Secretary position.**

16 **The foregoing Order was presented to the Tohono O'Odham Legislative Council on the 16TH. Day**
17 **of AUGUST, 2004 at a meeting at which a quorum was present, and by a vote of 569.65 FOR;**
18 **1,078.95 AGAINST; 981.1 NOT VOTING; and [03] ABSENT, failed to pass because it did not receive**
19 **a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono**
20 **O'odham Nation.**
