

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rejection of Membership Application of Adela Rodriguez)

1 **WHEREAS, an application for Enrollment as a member of the Tohono O'odham Nation has been**
2 **filed by or on behalf of:**

6 **filed on the 01 day of August, 1997; and**

7 **WHEREAS, the Enrollment Committee has reviewed the application and has recommended that**
8 **the application be denied because the applicant failed to establish the following**
9 **membership requirement(s):**

10 **TOHONO O'ODHAM CONSTITUTION, ARTICLE II, MEMBERSHIP-SECTIONS 1(A) AND**
11 **1(B); and**

12 **WHEREAS, the Enrollment Committee did serve written notice of its recommendation to reject**
13 **the application and of the rejection hearing; as required by Section 2, Article VI of the**
14 **Enrollment Ordinance, upon the person acting for the applicant or the sponsor; and**

15 **WHEREAS, the application has come on for hearing before the Legislative Council on August 24,**
16 **2004; and**

17 **WHEREAS, the Tohono O'odham Legislative Council has reviewed the evidence presented and**
18 **from such evidence finds that the applicant has failed to establish the foregoing**
19 **membership requirement(s).**


20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**
21 **determine that the application of: Adela Rodriguez for enrollment as a member of the**
22 **Tohono O'odham Nation is hereby rejected.**

23 **BE IT FINALLY RESOLVED that the Chairwoman of the Tohono O'odham Nation shall issue a**
24 **certificate of Final Determination of Rejection and that the Enrollment Committee**
25 **serve notice of Rejection of the application in accordance with the provisions of**
26 **Section 2, Article VIII of the Enrollment Ordinance.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
28 **of AUGUST, 2004 at a meeting at which a quorum was present with a vote of 2,028.45 FOR; 601.25**
29 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section**
30 **1 (h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**


