**WHEREAS, the Enrollment Committee has reviewed the application and has recommended that the application be denied because the applicant failed to establish the following membership requirement(s):**

**TOHONO O'ODHAM CONSTITUTION, ARTICLE II, MEMBERSHIP - SECTIONS 1(A) AND 1(B); and**

**WHEREAS, the Enrollment Committee did serve written notice of its recommendation to reject the application and of the rejection hearing; as required by Section 2, Article VI of the Enrollment Ordinance, upon the person acting for the applicant or the sponsor; and**

**WHEREAS, the application has come on for hearing before the Legislative Council on August 24, 2004; and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed the evidence presented and from such evidence finds that the applicant has failed to establish the foregoing membership requirement(s).**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby determine that the application of: Renna Renee Juarez for enrollment as a member of the Tohono O'odham Nation is hereby rejected.**

**BE IT FURTHER RESOLVED that the Chairwoman of the Tohono O'odham Nation shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve notice of Rejection of the application in accordance with the provisions of Section 2, Article VIII of the Enrollment Ordinance.**

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day of AUGUST, 2004 at a meeting at which a quorum was present with a vote of 2,028.45 FOR; 601.25 AGAINST; -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
