

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Gaming Distribution by Population)**

RESOLUTION NO. 04-436

1 **WHEREAS, during the September 10, 2004 Emergency Session, the Sells District did present for**
2 **the fourth (4th) time consideration by the Legislative Council the recommendation to**
3 **distribute gaming revenues by per capita/population; and**

4 **WHEREAS, the Legislative Council does hereby approve distribution of gaming revenues by**
5 **population.**

6 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
7 **approves and authorizes the distribution of gaming revenues by population to all the**
8 **districts retroactive to August 01, 2004.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
10 **of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,533.6 FOR; 1,096.1**
11 **AGAINST; -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section**
12 **1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
13 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
14 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
15 **Stat. 984).**


