(Memorandum of Agreement between the University of Arizona and the
Tohono O'odham Nation for the Planning, Design, and Development of a
Cultural Museum within the Tohono O'odham Nation)

RESOLUTION NO. 04-443

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 2000-275 appropriated funds for**
2 **the planning, design, construction, staffing and operation of a Cultural Center**
3 **/Museum; and**

4 **WHEREAS, the University of Arizona conducts programs of public service for the benefit of all**
5 **people of the State of Arizona; and**

6 **WHEREAS, the Arizona State Museum, University of Arizona, has experience in museum**
7 **development and education; and**

8 **WHEREAS, the Tohono O'odham Nation and the University of Arizona, together, developed a**
9 **Memorandum of Agreement; and**

10 **WHEREAS, the Cultural Preservation Committee of the Legislative Council has reviewed and**
11 **approves the Memorandum of Agreement.**

12 **NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council hereby agrees**
13 **to authorize joint development and implementation of specific programs and plans**
14 **for the museum including but not limited to building design, museum practice,**
15 **management, and planning activities pursuant to this Memorandum of Agreement.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the**
17 **Chairwoman of the Nation, to wit, to sign and execute the Memorandum of Agreement**
18 **Between the University of Arizona and the Tohono O'odham Nation.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
20 **of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,287.65 FOR; -0-**
21 **AGAINST; 342.05 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
