(Amending Legislative Order No. 04-225, "Setting September 27, 2004 Special Session for Revocation Rules Training Workshop")

9	Special Session for September 27, 2004 to address Revocation Rules Training

11	BE IT FINALLY ORDERED that Legislative Councilmembers are hereby mandated to attend the
12	Revocation Rules Training Workshop.

14	SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,546.55 FOR; 83.15
15	AGAINST; <u>-0-</u> NOT VOTING; and <u>[04]</u> ABSENT, pursuant to the powers vested in the Council by
16	Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
<b>17</b>	O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary .
18	Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
19	Stat. 984).
