

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Amending Legislative Order No. 04-225, "Setting September 27, 2004 Special Session  
for Revocation Rules Training Workshop")

LEGISLATIVE ORDER NO. 04-444

1 WHEREAS, according to the Legislative Rules, Article I, Section 1.D.1., "The Legislative Council  
2 may, by majority vote, call for a Special Session to be held for the purpose of  
3 completing unfinished agenda, addressing issues requiring Executive Session, and/or  
4 reviewing special reports from Committees, Programs, or other sources."; and

5 WHEREAS, the Legislative Council Rules Committee has requested that a Special Session be set  
6 for September 27, 2004 to address Revocation Rules Training Workshop to the Tohono  
7 O'odham Legislative Council.

8 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council has set a  
9 Special Session for September 27, 2004 to address Revocation Rules Training  
10 Workshop.

11 BE IT FINALLY ORDERED that Legislative Councilmembers are hereby mandated to attend the  
12 Revocation Rules Training Workshop.

13 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day of  
14 SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,546.55 FOR; 83.15  
15 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
16 Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
17 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
19 Stat. 984).
