1	WHEREAS,	with the support of the Hickiwan District, by Legislative Council Resolution No.04-
2		327, the Nation approved the transfer of financial management of the Hickiwan
3		District to the Nation for an indeterminate period of time; and
4	WHEREAS,	the policies and procedures of the Nation, requires that sources of funds must be
5		segregated into different accounts and that each account must be approved by
6		resolution of the Legislative Council; and
7	WHEREAS,	the Hickiwan District received a check in the amount of \$146,502.80 as replacement
8		for a cashiers' check that had been issued on October 26, 1998 and never cashed and
9		for which the current officials of the District had no knowledge until August 4, 2004;
10		and
11	WHEREAS,	the District determined that it was in the best interest of the District to immediately
12		deposit the check into an interest bearing account; and
13	WHEREAS,	Sacks Tierney P.A. agreed to open an interest bearing trust account to hold such
14		funds until such a time as the Hickiwan District and the Tohono O'odham Nation
15		could act to authorize and open a separate account for the Wachovia funds and
16		develop and approve a budget for the Wachovia funds; and
17	WHEREAS,	the Hickiwan District met in Special Session on September 9, 2004 and passed
18		Resolution Nos. 09-01-04 and 09-02-04 ratifying the actions of District officials and
19		taking action to seek Legislative Council approval to open an interest-bearing
20		account; and
21	WHEREAS,	on September 14, 2004, representatives and of ficials of the Hickiwan District met with
22		the Budget and Finance Committee and Legislative Council Representatives to
23		discuss the need to open an interest-bearing account.
24	NOW, THER	EFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council authorizes and
25		${\bf approves} the opening of a separate interest-bearing account for the Wachovia funds.$
26	BE IT FUR	THER RESOLVED THAT the Tohono O'odham Legislative Council authorizes the
27		Treasurer to transfer from the Valley First Community Bank to the Nation the amount
28		of \$146,502.80.
29	BE IT FINAL	LY RESOLVED THAT none of the Wachovia funds be expended except through a budget
30		prepared and approved by the Hickiwan District and approved by the Legislative
31		Council.
