1	WHEREAS, the current fiscal year expires on September 30, 2004 upon which the authority of the
2	Tohono O'odham Nation Government to expend appropriated funds shall cease; and
3	WHEREAS, the leadership of the Nation continue to examine the fiscal requirements of all
4	governmental operations and capital projects; and
5	WHEREAS, it is in the best interest of the Nation to enact the necessary authority to permit the
6	Nation's government (Executive, Legislative and Judicial Branch) funds to continue
7	governmental operations and approved projects beyond September 30, 2004.
8	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
9	authorizes the Tohono O'odham Nation's Government to expend funds at minimal
10	levels to continue all governmental operations and approved projects beyond
11	September 30, 2004.
12	BE IT FURTHER RESOLVED that all employee compensation shall remain at current levels until
13	such time that the Nation's fiscal year 2005 budget is formally adopted which may
14	authorize, retroactive to October 01, 2004.
15	BE IT FINALLY RESOLVED that this continuing authorization re-affirm the authority of the
16	Nation's Government (Executive, Legislative, and Judicial Branch) to expend funds
17	appropriated for capital projects.
