

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2004 Continuing Authorization for Pisinemo District)

RESOLUTION NO. 04-454

1 **WHEREAS, the fiscal year expires on September 30, 2004 and also the authority of the Pisin Mo'o**
2 **District to expend appropriated funds for the current fiscal year; and**

3 **WHEREAS, the Pisin Mo'o District is continuing operation at a limited level of services and**
4 **operations for at least one month after the end of the fiscal year; and**

5 **WHEREAS, it is in the best interest of the Pisin Mo'o District Council to ask the Legislative Council**
6 **for a Continuing Authorization to continue use of funds.**

7 **NOW, THEREFORE, BE IT RESOLVED that Pisin Mo'o District be authorized to expend funds beyond**
8 **September 30, 2004 or until monies for Fiscal year 2004-05 is disbursed.**

9 **BE IT FURTHER RESOLVED that all Employee Compensation remain at the current level until such**
10 **time that the Pisin Mo'o District Fiscal Year 2004-05 Budget is adopted and at which**
11 **time Employee Compensation will be adjusted retroactive to October 1, 2004.**

12 **BE IT FINALLY RESOLVED that the Legislative Council does approve for Pisinemo District to expend**
13 **funds to continue all operations, projects and services beyond September 30, 2004.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH, Day**
15 **of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629,7 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**






