1 **WHEREAS, Sells District is unable to forward its FY 2005 Budget to the Tohono O'odham**
2 **Legislative Council before the end of FY 2004; and**


3 **WHEREAS, it is in the best interest of the Sells District to continue its fiscal operations during the**
4 **interm period; and**

5 **WHEREAS, Sells District has sufficient funds left to cover its expenditures during this period.**

6 **NOW, THEREFORE BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves the**
7 **Sells District to continue to expend funds for, its regular operation at the FY 2004 level**
8 **until it's FY 2005 Budget has been reviewed and approved by the Tohono O'odham**
9 **O'odham Legislative Council.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH Day**
11 **of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
12 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
13 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
14 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
16 **18, 1934 (48 Stat. 984).**




