Attend the 61st N.C.A.I. Annual Convention, October 10, - 15, 2004 as Amended One Youth from
each District)

RESOLUTION NO. 04-458

1 **WHEREAS, the Tohono O'odham Legislative Council recognizes the Tohono O'odham Nation**
2 **Youth Council as the official voice of the Tohono O'odham Nation per Resolution No.**
3 **95-216; and**

4 **WHEREAS, the Legislative Council encourages a continual development of young Tohono**
5 **O'odham leaders by exposing them to leadership opportunities such as the National**
6 **Congress of American Indians (NCAI) Youth Commission; and**

7 **WHEREAS, the Tohono O'odham Legislative Council per Resolution No. 2000-020 supports the**
8 **Tohono O'odham Nation Youth Council to attend the NCAI Youth Commission**
9 **annually by allocating funds annually for a youth delegation to attend from the**
10 **Tohono O'odham Nation Youth Council; and**

11 **WHEREAS, the Tohono O'odham Nation Youth Council has brought forth a budget request in the**
12 **total amount of \$16,184.00; and**


13 **WHEREAS, this budget request will fund eleven (11) youth to attend the N.C.A.I. Youth**
14 **Commission's 61st Annual Convention that is to be held October 10-15, 2004 in Fort**
15 **Lauderdale, Florida.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports and**
17 **approves the Tohono O'odham Nation Youth Council budget request for NCAI in the**
18 **amount of \$16,184.00. One youth per district.**

19 **BE IT FURTHER RESOLVED that the funds in the amount of \$16,184.00 be appropriated from the**
20 **General Revenue Account.**

21 **The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 16TH.**
22 **Day of SEPTEMBER, 2004 at a meeting at which a quorum was present, and by a vote of 1,238.95**
23 **FOR; 1,390.75 AGAINST; -0- NOT VOTING; and [01] ABSENT, failed to pass because it did not receive**
24 **a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono**
25 **O'odham Nation.**
