**LEGISLATIVE ORDER NO. 04-459**

1 **WHEREAS, the Tohono O'odham Nation Youth Council is requesting for monetary support to**  
2 **attend the 61<sup>st</sup> Annual N.C.A.I. Convention October 10-15, 2004; and**

3 **WHEREAS, a proposal was submitted to the Legislative Branch for an amount of \$4,907.00 which**  
4 **exceeds the Legislative Branch Budget Contributions Line item which is capped at**  
5 **\$500.00; and**

6 **WHEREAS, the Chairwoman of the Tohono O'odham Nation does support a cost share with this**  
7 **council; and**


8 **WHEREAS, the Legislative Council does support the request for monetary donation.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorize the**  
10 **donation of \$4,907.00 to support the Tohono O'odham Nation Youth Council to attend**  
11 **the 61<sup>st</sup> Annual N.C.A.I. Convention to be held in Ft. Lauderdale, Florida.**

12 **BE IT FINALLY RESOLVED that the \$500.00 cap under the Contribution Line Item of the Legislative**  
13 **Branch Budget is hereby waived for this request.**

14 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day of**  
15 **SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,184.7 FOR; 445.0**  
16 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
17 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
20 **18, 1934 (48 Stat. 984).**
