

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the Use of Arizona Magic Wide Area Progressive System Contributions Fund
towards the Nation's Outstanding Balance of \$273,630.00 for the Proposition 202
Campaign Shortfall)

RESOLUTION NO. 04-461

1 **WHEREAS, the Tohono O'odham Legislative Council in Resolution No. 91-633 did appropriate**
2 **\$2,200,000.00 for the purpose of funding both the Arizona Indian Gaming Association**
3 **statewide government and public relations campaign, and the Nation's own**
4 **government and public relations efforts; and**

5 **WHEREAS, the Tohono O'odham Nation has received written communication from the Arizona**
6 **Indian Gaming Association (copy attached with enclosures) dated July 7, 2004**
7 **advising that the Nation does have an outstanding loan balance of \$273,630.00 for the**
8 **Proposition 202 campaign, a shortfall engrossed by the Ak-Chin, Fort McDowell, Gila**
9 **River, and Yavapai Apache tribes respectively; and**

10 **WHEREAS, at a meeting of Arizona Tribal Leaders on April 4, 2003, a majority of the Arizona**
11 **Indian Gaming Association membership agreed that each tribe would contribute an**
12 **additional 0.27%, for a total Proposition 202 campaign of 2.77% for each tribe**
13 **respectively, so that the final, total campaign cost would be shared in a**
14 **proportionately equitable manner; and**

15 **WHEREAS, the Tohono O'odham Nation has received two (2) bi-annually contribution checks**
16 **from Atronic Americas LLC for the Arizona Magic machines at Desert Diamond**
17 **Casinos; and**

18 **WHEREAS, the first check received was in the amount of \$112,563.95 and the second check was**
19 **in the amount of \$56,114.62 for a total bi-annual contribution to the Nation in the**
20 **amount of \$168,678.57; and**

21 **WHEREAS, with the combined total funds in the amount of \$168,678.57, the Tohono O'odham**
22 **Nation's outstanding balance to the Proposition 202 campaign shortfall remains at**
23 **\$104,951.43.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
25 **authorizes the use of Arizona Magic Wide Area Progressive bi-annual**
26 **contributions received by the Nation from Atronic Americas LLC in the amount**
27 **of \$168,678.57 towards the Nation's outstanding loan balance for the Proposition**
28 **202 campaign.**



3 **been determined.**


4 **BE IT FINALLY RESOLVED** that the Chairwoman is authorized to have payment processed in

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day**
7 **of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,534.0 FOR; -0-**
8 **AGAINST; 95.7 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
9 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
10 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
12 **18, 1934 (48 Stat. 984).**


