

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Intergovernmental Agreement with the University of Arizona
Regarding the Services of the Drachman Institute)

RESOLUTION NO. 04-466

1 **WHEREAS, in October 2003 the Tohono O'odham Nation ("Nation") purchased a 640 acre parcel**
2 **of land near Why, Arizona for use as a land base for the Hia-Ced O'odham; and**

3 **WHEREAS, the Nation's Hia-Ced O'odham Program ("Program") and the Hia-Ced O'odham**
4 **Advisory Committee ("Committee") have worked with the Nation's Department of**
5 **Natural Resources, Economic Development Department and Planning Department**
6 **to initiate land use planning and community development planning for the property;**
7 **and**

8 **WHEREAS, the Program and Committee also have a need for an outside consultant to gather**
9 **information and prepare a Master Land Use Plan for a Hia-Ced O'odham community**
10 **on the property, and have identified the Drachman Institute of the University of**
11 **Arizona as a source of such professional services; and**

12 **WHEREAS, the Program and Committee have negotiated an Intergovernmental Agreement with**
13 **the Drachman Institute in the form attached hereto, utilizing a budget of \$6,404.79,**
14 **and request Legislative Council approval of the agreement because the University of**
15 **Arizona is an entity of the State of Arizona; and**

16 **WHEREAS, this Intergovernmental Agreement has been reviewed by the Domestic Affairs**
17 **Committee and the Budget and Finance Committee, which recommend approval by**
18 **the Legislative Council.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **Intergovernmental Agreement with the University of Arizona regarding the services**
21 **of the Drachman Institute substantially in the form attached hereto and authorizes**
22 **the Chairwoman of the Nation to execute it, and further authorizes the Program to**
23 **expend the funds shown in the budget for the agreement, with the understanding that**
24 **expenditures in FY 2005 are dependent on approval of the Program's FY 2005 budget**
25 **in accordance with the usual procedures of the Nation.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day**
27 **of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,544.55 FOR; -0-**
28 **AGAINST; 85.15 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
29 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**
