

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Requesting Tohono O'odham Nation's Gaming Board to Approve and Fund a
Feasibility Study in the Town of Florence in Pinal County)

RESOLUTION NO. 04-467

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on September 17, 2004 during**
2 **their September General Session to address matters pertaining to the Nation; and**
3 **WHEREAS, the population of the town of Florence and vicinity has been growing with a proposed**
4 **new development estimated to bring 28,000 future homes; and**
5 **WHEREAS, non-members from the town of Florence have questioned Florence Community**
6 **residents on, "Why the Tohono O'odham Nation has not considered the Florence**
7 **Community for a Gaming Facility?"; and**
8 **WHEREAS, non-members from the town of Florence have suggested that a Gaming Facility be**
9 **built near Florence; and**
10 **WHEREAS, the Gu Achi District believes there is a strong potential for economic ventures in**
11 **and/or near the town of Florence.**
12 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council requests that**
13 **the Tohono O'odham Gaming Board approve, fund, and conduct a Feasibility Study**
14 **in the town of Florence in Pinal County for a possible gaming facility and potentials**
15 **for future economic ventures.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day**
17 **of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,103.0 FOR; 1,091.7**
18 **AGAINST; 435.0 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
20 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat. 984).**




