7		Community for a Gaming Facility?"; and
8	WHEREAS,	non-members from the town of Florence have suggested that a Gaming Facility be
9		built near Florence; and
10	WHEREAS,	the Gu Achi District believes there is a strong potential for economic ventures in
11		and/or near the town of Florence.
12	NOW, THER	EFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council requests that
13		the Tohono O'odham Gaming Board approve, fund, and conduct a Feasibility Study
14		in the town of Florence in Pinal County for a possible gaming facility and potentials
