

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Continuing Resolution for Chukut Kuk District for FY 2004)**

RESOLUTION NO. 04-471

1 WHEREAS, the 2004 fiscal year is ending on September 30, 2004; and  
2 WHEREAS, District operations are funded by the gaming revenue allocation; and  
3 WHEREAS, Chukut Kuk District has not been awarded funding as of September 16, 2004 for fiscal  
4 year 2005; and  
5 WHEREAS, in order for District operations to continue without interruption, a continuing  
6 resolution is necessary; and  
7 WHEREAS, Chukut Kuk District is requesting authorization to continue operating at the FY 2004  
8 spending level until such time as the District's FY 2005 budget is approved and funds  
9 are awarded.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
11 a continuing resolution as requested by Chukut Kuk District.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup> Day  
13 of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-  
14 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by  
15 Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18 18, 1934 (48 Stat. 984).
