3 **WHEREAS, the Baboquivari District is unable to forward their FY05 budget pending final**
4 **approval with the Tohono O'odham Legislative Council.**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
6 **continued operations for the Baboquivari District FY04 Budget pending approval of**
7 **the district's FY05 budget.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day**
9 **of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
10 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
11 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
12 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
14 **18, 1934 (48 Stat. 984).**




