

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Continuing Resolution for FY 05 Schuk Toak District Budget)

RESOLUTION NO. 04-473

1 WHEREAS, the Schuk Toak District presented to the Tohono O'odham Legislative Council a
2 request for approval of a continuing resolution for District operations; and

3 WHEREAS, the Schuk Toak District Council met in Special Session on September 15, 2004 at 6:00
4 p.m. to discuss the Schuk Toak District FY05 budget; and

5 WHEREAS, the Schuk Toak District Council was advised of the approval by the Executive Office
6 for the Gaming monies to be distributed by population to the districts of the Tohono
7 O'odham Nation; and

8 WHEREAS, the Schuk Toak District Council wishes to wait until an actual amount for the
9 distribution of Gaming monies to the district is made available before discussing and
10 approving the District FY05 budget; and

11 WHEREAS, the Schuk Toak District Council approved a continuing resolution at current levels
12 until October 31, 2004 for final approval of the district FY05 budget; and

13 WHEREAS, there are sufficient funds in the District's accounts with Wachovia Securities for
14 continued operations pending final approval of the FY05 budget.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
16 the continuing resolution for the Schuk Toak District until October 30, 2004.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH. Day
18 of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-
19 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
20 Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
21 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
22 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
23 18, 1934 (48 Stat. 984).
