

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the San Xavier District to Continue Governmental Operations
through November 30, 2004)

RESOLUTION NO. 04-474

1 **WHEREAS, the San Xavier District Council has enacted Res. No. SXDC 09-04-06 requesting the**
2 **Tohono O'odham Council to authorize its continued governmental operations until**
3 **their FY05 budget is reviewed and approved by the San Xavier District Council and**
4 **Community, and ultimately by the Tohono O'odham Council; and**

5 **WHEREAS, the District has the necessary funding to continue operating at FY04 levels until their**
6 **FY05 budget is passed.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
8 **authorizes the San Xavier District to continue operating at FY04 levels until the final**
9 **passage of their FY05 budget but no later than November 30, 2004.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day**
11 **of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
12 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
13 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
14 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
16 **18, 1934 (48 Stat. 984).**


