

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Lucy District to Continue District Operation - Pending
Approval of the FY 2005 San Lucy District Budget)

RESOLUTION NO. 04-475

1 WHEREAS, sufficient funds in the amount of \$192,029.90 have been identified by San Lucy
2 District to continue district operation pending approval of their FY 2005 Budget; and


3 WHEREAS, the Tohono O'odham Legislative Council is delegated the fiduciary responsibility to
4 approve budgets and modifications thereof; and

5 WHEREAS, the Tohono O'odham Legislative Council recognizes that due to lateness in
6 determining distribution of Gaming Revenues districts have insufficient time to
7 prepare their FY 2005 Budget, and disruption of services and staff lay-off would cause
8 irreparable effects on members.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
10 the San Lucy District to continue district operations pending approval of the FY 2005
11 Budget.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day
13 of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; ~~-0-~~
14 AGAINST; ~~-0-~~ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
15 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
16 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
18 Stat. 984).


