**RESOLUTION NO. 04-478**

1 **WHEREAS, the National Congress of American Indians (NCAI) will hold its 61<sup>st</sup> Annual Session in**  
2 **Fort Lauderdale, Florida on October 10-15, 2004; and**

3 **WHEREAS, the Tohono O'odham Nation is a long time member in good standing with the**  
4 **National Congress of American Indians; and**

5 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to renew its membership in the**  
6 **National Congress of American Indians.**


7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
8 **authorizes the following members to attend and serve as the Tohono O'odham**

19 **payment of NCAI membership dues for the Tohono O'odham Nation in the amount of**  
20 **\$5,000.00 from the Legislative Branch dues and subscriptions line item.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup> Day**  
22 **of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 1 (b), (d)(2) and (j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
25 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
