

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Revocation of Membership of Michael L. George from the Tohono O'odham Nation)

RESOLUTION NO. 04-495

1 WHEREAS, Article IX, Section 2 (A) of the Tohono O'odham Nation Enrollment Ordinance
2 provides *membership in the Nation and all rights deriving therefrom shall be lost or*
3 *abandoned if a person is or becomes enrolled as a member in another Indian nation,*
4 *tribe, community or band; and*

5 WHEREAS, the Enrollment Committee has determined that Michael L. George, is enrolled as a
6 member of the Tohono O'odham Nation and is also enrolled as a member of Coeur
7 d'Alene Tribe; and

8 WHEREAS, Michael L. George was given an opportunity to relinquish membership in accordance
9 with Article IX, Section 2(A) of the Enrollment Ordinance, but has failed or refused to
10 do so; and

11 WHEREAS, the foregoing person did not relinquish membership with the Tohono O'odham
12 Nation and the Enrollment Committee therefore recommends that his/her
13 membership in the Tohono O'odham Nation be revoked; and

14 WHEREAS, the Enrollment Committee did serve written notice of its recommendation upon the
15 foregoing person or, if a minor or incompetent, upon the parent, guardian or other
16 person legally authorized to act on his or her behalf as required by Article IX, Section
17 2 (C) of the Enrollment Ordinance; and

18 WHEREAS, the Tohono O'odham Legislative Council has reviewed the Enrollment Committee's
19 recommendation and all evidence presented, and from such evidence finds that the
20 foregoing person is enrolled as a member of Tohono O'odham Nation and is also
21 enrolled as a member of Coeur d'Alene Tribe.

22 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does
23 hereby revoke the membership of Michael L. George in the Tohono O'odham Nation
24 and that the Enrollment Committee serve notice of this determination to, Michael L.
25 George in accordance with Article IX, Section 2 (D) of the Enrollment Ordinance.

26 BE IT FINALLY RESOLVED that upon completion of all appeals from this determination or upon
27 expiration of the time allowed for such appeals, as provided in Article IX, Section 2 (E)
28 of the Enrollment Ordinance, the name of the foregoing person who failed to appeal
29 or to succeed in their appeal shall be removed from the membership roll of the
30 Tohono O'odham Nation.

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day
2 of SEPTEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,766.2 FOR; 863.5
3 AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by
4 Section 2 (A) of Article IX of the Constitution of the Tohono O'Odham Nation, adopted by the
5 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
7 18, 1934 (48 Stat. 984).
