## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Revocation of Membership of <u>Junaluska Montelongo</u> from the Tohono O'odham Nation)

RESOLUTION NO. 04-502

1	WHEREAS,	Article IX, Section 2 (A) of the Tohono O'odham Nation Enrollment Ordinance
2		provides membership in the Nation and all rights deriving therefrom shall be lost or
3		abandoned if a person is or becomes enrolled as a member in another Indian nation,
4		<i>tribe, community or band</i> ; and
5	WHEREAS,	the Enrollment Committee has determined that <u>Junaluska Montelongo</u> is enrolled
6		as a member of the Tohono O'odham Nation and is also enrolled as a member of <u>Nez</u>
7		Perce Tribe; and
8	WHEREAS,	<u>Iunaluska Montelongo</u> was given an opportunity to relinquish membership in
9		accordance with Article IX, Section 2(A) of the Enrollment Ordinance, but has failed
10		or refused to do so; and
11	WHEREAS,	the foregoing person did not relinquish membership with the Tohono O'odham
12		Nation and the Enrollment Committee therefore recommends that his/her
13		membership in the Tohono O'odham Nation be revoked; and
14	WHEREAS,	the Enrollment Committee did serve written notice of its recommendation upon the
15		foregoing person or, if a minor or incompetent, upon the parent, guardian or other
16		person legally authorized to act on his or her behalf as required by Article IX, Section
17		2 (C) of the Enrollment Ordinance; and
18	WHEREAS,	the Tohono O'odham Legislative Council has reviewed the Enrollment Committee's
19		recommendation and all evidence presented, and from such evidence finds that the
20		foregoing person is enrolled as a member of Tohono O'odham Nation and is also
21		enrolled as a member of <u>Nez Perce Tribe</u> .
22	NOW, THER	REFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does
23		hereby revoke the membership of <u>Junaluska Montelongo</u> in the Tohono O'odham
24		Nation and that the Enrollment Committee serve notice of this determination to
25		<u>Iunaluska Montelongo</u> , in accordance with Article IX, Section 2 (D) of the
26		Enrollment Ordinance.
27	BE IT FINAL	LY RESOLVED that upon completion of all appeals from this determination or upon
28		expiration of the time allowed for such appeals, as provided in Article IX, Section 2 (E)
29		of the Enrollment Ordinance, the name of the foregoing person who failed to appeal
30		or to succeed in their appeal shall be removed from the membership roll of the
31		Tohono Oʻodham Nation.
