15                   and that their application is approved, as herein above indicated.

16 **BE IT FURTHER RESOLVED** that the Chairman and other appropriate officers of the Tohono  
17                   O'odham Nation reduce this final determination in writing regarding each of the  
18                   foregoing applications for enrollment in accordance with Section 1(a) of Article  
19                   XIII of the Enrollment Ordinance; give notice of this Council's determination in  
20                   accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place  
21                   the names of each applicant upon the membership roll of the Tohono O'odham  
22                   Nation in accordance with Sections 2 and 3 of Article X of the Enrollment  
23                   Ordinance.

24 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 18<sup>th</sup>. Day**  
25 **of OCTOBER 2004 at a meeting at which a quorum was present with a vote of 1,526.5 FOR; 1,103.2**  
26 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham**  
28 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
30 **of the Act of June 18, 1934 (48 Stat. 984).**
