RESOLUTION NO. 04-526

1 **WHEREAS, the Tohono O'odham Nation recognizes the importance of Tohono O'odham Nation**
2 **members participating in the democratic process as citizens of the United States of**
3 **America; and**

4 **WHEREAS, the Democratic candidate for Arizona State Representative, District 25, Monica Perez**
5 **has expressed her desire to be supportive of tribal governments; and**

6 **WHEREAS, Ms. Monica Perez has voiced her desire to maintain and enhance the relationship**
7 **between the Tohono O'odham Nation and her office should she be elected.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation endorses the Democratic**
9 **candidate for Arizona State Representative, District 25, Ms. Monica Perez.**


10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH Day**
11 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 1,964.45 FOR; -0-**
12 **AGAINST; 660.25 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
13 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
14 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
15 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
16 **Stat. 984).**




